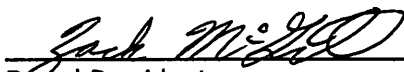

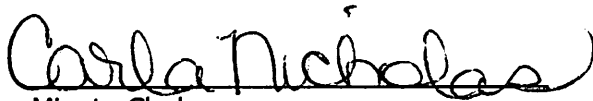
The new Superintendent Rick Croslin will be starting full time on March 23, 2020
