Chickasha Public School district is participating in the Summer Food Service Program (SFSP), which provides nutritious meals at no charge to children during summer vacation. Children aged 1-18, regardless of race, color, national origin, sex, age, or disability, are eligible to receive meals through the SFSP. A person 19 years of age and over, who has a mental or physical disability (as determined by a state or local education agency) and who participates during the school year in a public or private, non-profit school program (established for the mentally and physically disabled) is also eligible to receive meals. Meals will be provided at the sites and times as follows:
